- d) Any clause or article of the MOU may be modified or amended by mutual agreement of The Health Care and **SVP COLLEGE OF PHARMACY, HATTA**.

ARTICLE-VI: IPR

Rights regarding publications, patents, royalty, ownership of software/design/product developed etc. under the scope of this MOU, shall be decided by the two parties by mutual consent.

ARTICLE-VII: CONFIDENTIALITY

During the tenure of the MOU both **SVP COLLEGE OF PHARMACY, HATTA** and The Health Care will maintain strict confidentiality and prevent disclosure of all the information and data exchanged under the scope of this MOU for any purpose other than in accordance with this MOU

Both **SVP COLLEGE OF PHARMACY, HATTA** and The Health Care shall bind their respective personnel who come into possession or knowledge of any confidential information not to disclose the same to third parties without written approval of the disclosing party or use such confidential information for any use other than intended under this agreement or PROJECTS.



Further both **SVP COLLEGE OF PHARMACY, HATTA** and The Health Care shall put in place adequate and reasonable measures to keep and store confidential information secure so as to prevent any unauthorized use.

CONFIDENTIAL INFORMATION shall mean any proprietary information, data or facts belonging to PARTIES collectively or severally, disclosed by the disclosing party under this agreement or any subsequent agreement. Whether in writing, verbal or electronically, irrespective of the medium in which such information is stored, which is marked confidential or with any other words having similar meaning by the disclosing party, or specifically agreed to be kept confidential by the parties, or declared or identified so by the disclosing party before such disclosure or during the discussions.

#### ARTICLE-VIII: AMENDMENTS



## ARTICLE-II: SCOPE AND TERMS OF INTERACTIONS

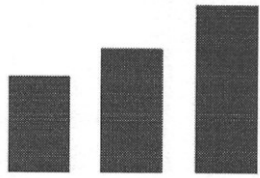

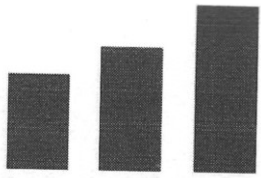

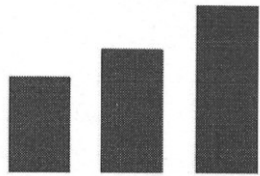
## ARTICLE-IV: CO-ORDINATION OF THE PROGRAMME INCLUDING FINANCIAL ARRANGEMENTS

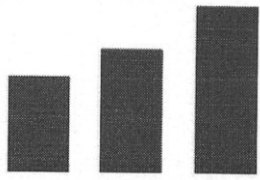

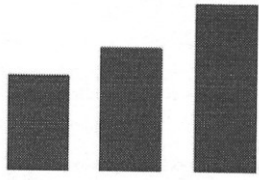
