

What is Ragging? Any Act Resulting in:

- Mental/physical/sexual Abuse
- Verbal Abuse
- Indecent Behaviour
- Criminal Intimidation/wrongful Restraint
- Undermining Human Dignity
- Financial Exploitation/extortion
- Use Of Force

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission,
- Suspension from attending classes,
- Withholding/withdrawing Scholarship/Fellowship and other benefits,
- Debarring from appearing in any test/examination or other evaluation process,
- Withholding results,
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.,
- Collective punishment : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure conformity pressure on potential raggers.




Anybody indulging in Ragging will be severely punished.
